1. The successful Contractor would have to make following payments in respect to the contract:-
 - (a) Security Deposit - Rs. 10,000/-
 - (c) Water Charges P.M. - on actual extra
 - (d) Electricity Charges - on actual extra (kitchen area only)
 - (e) Rental charges- As per bid
 - (e) Service charges- As applicable
2. The Contract would be for duration of three years (this period will start 1st July 2018).
3. The timing and the working days of Mess and Canteen services will be regulated by the College.
4. The contractor shall not cause any damage to the premises and movable asset given to him by the College and will hand-over back in the same condition as it has been leased to him and it will be his responsibility to keep the premises in perfect conditions.
5. The contractor shall use the premises to carry on the trade of Canteen only. The contractor shall not put the premises to any other use including allied or ancillary trade without the prior written consent of the college authority.
6. The Contractor shall keep the premises of the canteen and the surroundings neat and clean failing which fine @ Rs.500/- to Rs. 5000/- will be imposed.
7. The Principal and his nominees shall have access to the premises at all reasonable time to inspect and see for himself that the agreed conditions are strictly adhered to by the contractor.
8. The contractor shall not commit any act of omission, which is detrimental to the interests of the college in any manner and non-compliance to the same will amount to automatic termination of contract and forfeiture of security.
9. If the contractor or any of its staff will misbehave with any of the students and staff and non-compliance to the same will amount to automatic termination of contract and forfeiture of security.
